- ❖ Informed attendees of the next public meeting on August 24, 2022 at City Church San Antonio, 9431 Bandera Road 78250 from 5:00 until 8:00pm

## **Larry Clark- Bender Wells Clark Design**

- Provided a brief description of the site and overview of what elements are on the property now
- Gave a review of the Master Plan created in 2019
- Provided an overview of the improvements mentioned in the Master Plan and Bond language, including 2 separate items:
  - 1. \$1,675,000 for O.P. Schnabel Park to construct general park improvements within available funding which may include roadway improvements to expand access to park areas, bicycle park, and playground amenities.
  - 2. \$3,250,000 for Citywide Bicycle Recreational Facilities to develop and construct new bicycle facilities to include BMX and Mountain Bike recreational opportunities located at O.P. Schnabel Park, Eisenhower Park and Pearsall Park within available funding.
- Asked for input from participants on elements they would like to see
- Reviewed next steps for development of the project

#### **Public list of comments**

- ❖ Where will the entry be? *Answer:* The entry will remain where it is (to the driving range).
- ❖ Why is the bike park located in the south of the property near the houses? Answer: This was the location that was agreed upon when the Master Plan was done in 2019. The bike park should not generate a lot of noise or trash. □ The residents stated that they can hear the noise from the cricket pitch inside their homes when there are people playing □ The roadway to the bike park should not be near the residences.
- Try to encourage bike riders to access the new facility from the existing trails at O.P. Schnabel to the east of the new property.
- ❖ Build out a slower bike loop trail around the perimeter to keep the speed slow for young and not so experienced riders. □ Try to use terrain or planting to buffer the sound
- Mostly suburban families will be using the new facilities
- ❖ Build elements for the intermediate and expert riders before the money runs out (elements not found at Pearsall or McAllister Park)
- There are serious drainage issues on the site (takes down residents' fences and ponds at the entry to the property)
- Study what makes sense for access







- Try to use the existing parking as much as possible (don't need to spend money on a bunch of new asphalt)
- Something needs to be done about the deer population (one rider mentioned potential conflicts with riders)
- Try to get the City drainage folks to clean up the greenbelt along the property line of residents
- ❖ There can be 3' to 5' of water running behind their property in a large rain (moves through very quickly)
- Concern about traffic impacting the neighborhoods since there are no sidewalks and there is limited access to this area of the park
- Right now, the existing parking lot is underutilized
- ❖ People are coming from all over to use the trails now
- Most of the mountain bikers can access the new areas form the existing green way trails
- Raise the bar on what elements are added- elevate skills levels. Focus on skills progression
- Make sure we address getting kids and families out on the property
- Consider connections to nearby schools and any school programs/ sports that might utilize the bicycle complex
- Make sure we spend the money on actual recreational bike facilities; there was a great effort to place bike facilities in the bond.
- ❖ Most mountain bikers clean up after themselves and are not noisy
- Residents are worried about the property being maintained since they do not believe it is getting maintained now, especially the drainage areas and fence line.
- ❖ The maintenance and drainage issues were not resolved when the City acquired the property and this needs to be addressed
- Minimize the amount of asphalt
- Don't need a picnic pavilion in the bicycle complex.
- ❖ Interior roadway as designed in the master plan is a bad idea might get washed out by the drainage.
